Contract for the hire of weights and the terms and conditions of hire.



1. We have a total of up to 20000kg of 1000kg weights available for hire, subject to availability at the time of booking.
2. All weights are calibrated and fully traceable to national standards and supplied with a current statement of traceability.
3. Each 1000kg weights will be accurate to within the OIML M1-2 accuracy classification (+/-100g)
4. Hire of set (20,000 kg) or part thereof will be charged at the rate of **£478.80 per calendar day**.
5. Weights will be made available to you in a clean condition ready for use. All weights shall be returned to us in a clean state.
6. If the weights are returned to us in a dirty condition, we reserve the right to charge for the cleaning of the weights at the rate of £60.65 per hour.
7. If any weights are returned to us in a damaged condition or become lost during your period of hire we reserve the right to pass onto you the cost of replacing and calibrating such weights in addition to any other costs incurred as a result of the damage or loss.
8. Where possible you will inform us of your intended period of hire at the time of booking so that we can ensure suitable availability of weights for your period of hire.

13. Whilst every effort is made to provide the services outlined above West Yorkshire Joint Services will not be liable for costs incurred if it is not possible to provide any of these services due to circumstances beyond its control.
14. You will be responsible for collection and return of the weights to and from West Yorkshire Joint Services premises, unless a separate agreement for this has been made with us in advance of the hire.
15. We are open to receive deliveries and collections Monday to Friday between 9am and 4pm.
16. You will provide an order number for the work to be undertaken by the time of submission. You can email purchase orders to calibration@wyjs.org.uk.
17. Accounts will be subject to a credit check if a credit account is required. We require invoices to be paid within 30 days from date of issue. Also, we don't issue pro forma invoices.
18. All prices quoted above exclude Value Added Tax which is payable at the standard rate on all hiring's.
